

LA LEGISLATION UPDATE

Louisiana House Bill 683 was enacted on 6/13/2020 to amend and reenact R.S. 40:1646(B), 1664.8, 1664.9(D)(3), (K), and (L), and 3 1664.11(B)(1), to enact R.S. 40:1664.5.1 and 1664.9(D)(4), (M), and (N), and to 4 repeal R.S. 40:1664.5(A)(12), relative to life safety and property protection 5 licensing; to provide relative to annual inspections of life safety and property 6 equipment; to provide relative to exceptions for certain building owners; to provide 7 limited exemption for electrical contractors; to provide relative to criminal 8 background checks; to provide requirements for conveyance device mechanic 9 license; to provide with respect to temporary and emergency conveyance device 10 mechanic licenses; to provide for fees; to provide with respect to the Life Safety and 11 Property Protection Education Board; to provide for an effective date; and to provide 12 for related matters.

ESCM Manufacturing, Inc.

ESCM Manufacturing Inc. is a New York based company that develops a unique contact monitoring system that delivers state-of-the-art fault monitoring of elevator safety devices.

THE CHALLENGE

Implementing a reliable and code-compliant safety monitoring system for elevators

Elevators have separated branch circuits that include the hoistway, the car, and the machine room, which represents a measure of safety to those maintenance persons working on the elevator. One of the biggest issues faced when installing and repairing elevators is the troubleshooting of electrical safety devices - technicians and elevator mechanics must jump out the safety devices or remove their covers for contact inspection.

As of January 1, 2020, the elevator industry has been regulated by a new code - all NYC automatic passenger and freight elevators must be able to detect jumped and faulty door circuits in order to be considered compliant. While other manufacturers develop DLM (door lock monitors) to conform to new code requirements, ESCM Manufacturing has delivered unprecedented microprocessor-based technology - monitoring and troubleshooting of elevator safety devices.

Main project requirements

The main challenge was to develop a safe and code compliant monitoring system to inform technicians on the state of the elevator safety devices.

THE SOLUTION

A monitoring safety system based on the Arduino Nano

With an Arduino Nano implemented, the ESCM2000 Monitor and Display Board supports elevator technicians

during the troubleshooting procedure of elevator safety devices by giving an observable indication of the status of the device being monitored: a red blinking LED represents an open contact, and a green LED represents a closed contact. Moreover, the ESCM2000 has been designed to be independent of any other device, allowing for remote monitoring and eliminating the need for unnecessary jumping out of safety circuits.

Implementing the Arduino Nano gave the ESCM2000 advanced functionality and programming ability



allowing for an addressable component and the ability to send data to any desired location for viewing on LCD via RS485 or CANBus. Two rotary DIP switches allow for easy programming of any address from 00-99 efficiently transforming any safety device into an addressable device.

ESCM2000 was designed based upon three core deliverables:

- · Visual fault monitoring
- Ability to identify improperly wired safety circuits, short circuits in the safety string and jump out safety devices
- Realtime annunciation of the status of each safety device monitored

In Memoriam



Elevator industry influencer, Marie McDonald, passed away on May 31, in Hemet, California. A mover and shaker, Marie helped pave the way and stamped a mark for women in the industry. In the late 1950's, she significantly contributed in the formation of the West Coast Chapter of the

National Association of Women in Construction, and in 1958, became the first woman to receive an elevator license in California. She also earned her QEI certification through NAESA International and was elected to NAESA's Board in 1976 where she served as Treasurer for 17 years. Soon after in 1977, she founded McDonald Elevator Co., an elevator-inspection firm, where she landed a multiyear U.S. government contract covering elevator inspections in 10 states, including the U.S. Postal Service and the Government Services Administration. In the mid-1980s, she became the first woman certified elevator inspector in the U.S., and in 1988, her hard work and determination earned her Entrepreneur of the Year by the San Francisco Chamber of Commerce.

A long-time member of NAEC, Marie served on the Board from 1989 to 1991. Highly recognized as an inspiration

to many in our association, she received the President's Award in 1990 and the William C. Sturgeon Distinguished Service Award in 2001. She also served as chairperson for the Elevator Escalator Safety Foundation (EESF) for many years.

After her husband, John McDonald, passed away in 1989, Marie sold her company and worked for Pacific Access Contractors in Redwood City, California, until her retirement

in 2013. She remained an NAEC member and was appointed an Honorary membership in 2008. Marie is survived by her children, Kimara, Lori and Adam; grandchildren, Garrett, Michaela and Stephanie; and five greatgrandchildren.


